

DANGEROUS DRUGS: FOSAMAX

steoporosis is a disease that causes thinning of bone tissue and loss of bone density over time that eventually leads to an increased risk of bone fractures occurring throughout the body. This disease affects approximately 44 million Americans. There are an estimated 10 million people that already have the disease, and an estimated 34 million that are at risk for the disease due to loss of bone mass. Physicians commonly prescribe medications from a class of drugs called bisphosphonates, which are used to treat and prevent the onset of osteoporosis. Bisphosphonates act to strengthen existing bone mass and prevent any loss of future bone mass.

Fosamax is an oral bisphosphonate developed and distributed by Merck & Company, Incorporated and was approved by the United States Food & Drug Administration in 1995. By 2007, Fosamax sales totaled \$3 billion. Along with being used to treat osteoporosis, Fosamax is also used to treat bone cancer (preventing loss of future bone mass), and is used to treat and prevent Paget's disease (disease that causes softening and weakening of bone tissue).

Recent studies have shown that **Fosamax** usage has been linked to the occurrence of osteonecrosis of the jaw (ONJ), in long term users. ONJ, also called "Dead Jaw", is a condition that destroys the jaw bone tissue. This disease usually occurs after minor traumas in the mouth resulting from oral surgeries or tooth extraction, where the mouth and jaw do not fully recover from the surgery and an infection develops. This is followed by the bone becoming exposed in the mouth, as it is decaying.


Merck & Company, Inc. failed to disclose the risk of ONJ on the warning label of Fosamax and recently amended and revised their warning label to currently reflect the potential risk of developing ONJ, in March of 2010. Merck's defective design of Fosamax accompanied with their failure to warn of the risk of devel-



oping ONJ, has led to a great deal of products liability litigation throughout the country.

In August of 2010, after a home game, New York Mets' closing pitcher, Francisco Rodriguez, lashed out at his girlfriend's father, repeatedly punching him in the head and face and hospitalizing him. In September of 2010, a Tarrytown

city employee, Anthony Ruggiero, climbed into a manhole to investigate a blocked sewer, and quickly succumbed to toxic fumes. John Kelly, a volunteer Tarrytown firefighter, bravely entered the manhole in an attempt to save Ruggiero. Mr. Kelly was also overcome by fumes, and both men died. Gersowitz Libo & Korek has been asked to represent the family of John Kelly as they seek justice for this tragic and preventable death.

WHEN A SCAFFOLD IS NOT ENOUGH SUPPORT

Protecting the Safety of New York's Construction Workers

ersowitz Libo & Korek, P.C. has a long history of fighting for the rights of construction workers and their families in the New York area. We believe that workers' safety is of the utmost importance and that employers should do everything in their power to make sure that their worker's health and welfare are protected. Unfortunately, in New York, as developers and construction companies push forward with new development, construction workers' safety is often compromised in the interest of speed and frugality.

Here at Gersowitz Libo & Korek, P.C. we have represented workers and their families in a wide range of construction related accidents including crane accidents, ladder and scaffold collapses and demolition injuries. Even in New York, which has a comprehensive body of labor laws in place to protect workers, such incidents are still unfortunately too common an occurrence. According to the Bureau of

Construction is one of the most dangerous industries nationally.


Labor and Statistics, construction is one of the most dangerous industries nationally, accounting for over 20% of all workplace deaths in 2009.¹

Even though Labor Law Sec. 240, known as the "Scaffold Law" is in place to protect construction site employees working at elevated heights,

accidents involving falls from high places still remain a leading case of injury and death at New York construction sites. Nationally, almost a third of the construction fatalities referenced above for 2009 involved falls from elevated heights at construction sites.2 While big insurance companies, contractors and building owners are seeking to gut the Scaffold Law by effectively shifting onto workers the ultimate responsibility for worksite safety, at GLK we believe responsibility should remain with owners and contractors at worksites, the parties who control the ability to make the sites safer.

GLK has represented construction workers and their families in a wide variety of cases and has successfully obtained recoveries on behalf of many injured construction workers in the New York and New Jersey area, including:

• A settlement in the amount of \$7.5 million was reached in the third week of trial on behalf of the surviving eight children of a 38 year old construction worker. During the course of his employment, the construction worker was caused to fall off of a Bobcat machine rendering him a quadriplegic. Subsequently, the construction worker died as a result of complications of his injuries.

- A settlement in the amount of \$2.5 million was reached in Bronx County on behalf of the estate of a 44 year old ironworker's apprentice. The apprentice was performing work on the underside of a bridge when he was caused to fall to his death due to improper safety precautions at the worksite including improper scaffolding and fall protection.
- A settlement in the amount of \$2 million was reached in Queens County on behalf of a 43 year old construction worker who fell off of a scaffold while performing work at a property in Westchester County. The worksite had improper scaffold-
- ing which was strewn with debris. Additionally, our client was not provided with a proper lifeline to prevent a fall. Our client suffered a traumatic brain injury, a fractured elbow and a fractured back as a result of the incident and requires long term care.
- A verdict was reached in the sum of \$1,712,721, which was affirmed on appeal in the Appellate Division, Second Department on behalf of a 53 year old electrician who received an electrical shock while working on a runway at JFK airport. The Port Authority of New York and New Jersey failed to make sure that all electrical currents were off in the area

even though it was known that electrical work was being done on the runway.

At Gersowitz Libo & Korek, P.C. we remain dedicated to strengthening the Labor Law provisions in place in New York State and we will continue to fight for the rights of both documented and undocumented workers.

SETTLEMENTS & VERDICTS

Recent Wins from GLK

Motor Vehicle/Sanitation Truck — A settlement was reached on the last day of a four week trial in the amount of \$9.5 million in Queens County on behalf of a 23 year old real estate project manager and father who was struck by a sanitation truck while riding his motorcycle. Our client was required to undergo an above the knee amputation, also known as a left hip disarticulation. He underwent 15 surgeries related to this incident.

Medical Malpractice/Foreign Body — A jury returned a verdict in the amount of \$3 million in Bronx County on behalf of a 52 year old married father of two. During a radical prostatectomy, the doctor and surgical team assisting in the procedure failed to ensure that all of the surgical tools used during surgery were accounted for. As a result, they left a piece of umbilical tape inside our client's body at the end of the procedure. Our client suffered urinary problems as a result of this and was forced to wear adult diapers for a period of time. Our client also underwent 16 separate procedures to correct the mistake, one of which included the permanent placement of an artificial sphincter.

Medical Malpractice/Wrongful Death — A settlement in the amount of \$2,750,000 was achieved in New York County on behalf of the family of a 33 year old jeweler and musician who died after innocently being shot in a holdup. The hospital where he was taken failed to timely perform surgery.

Medical Malpractice/Failure to Timely Perform Surgery — A settlement in the amount of \$2.4 million was reached in Bronx County on behalf of the Estate of a 50 year old father of three. Our client went into the hospital after experiencing complications from an untreated gall bladder infection. During our client's admission to the hospital, doctors failed to timely perform surgery and failed to timely institute antibiotic coverage. This delay in treatment caused our client to develop pneumonia and Acute Respiratory Distress Syndrome which subsequently resulted in

his death.

Motor Vehicle/Wrongful Death — A settlement in the amount of \$1.5 million was reached on behalf of the family of two boys, one of whom was fatally struck by a commercial vehicle which ran a red light while they were walking home from school. A settlement on behalf of his older brother was achieved due to his proximity in witnessing the accident.

Medical Malpractice/Failure to Diagnose — A settlement in the amount of \$1.3 million was reached in Mercer County, New Jersey on behalf of the Estate of a 48 year old husband and father of three minor children who died after doctors at the facility where he was undergoing treatment failed to diagnose his heart condition.

Motor Vehicle/Pedestrian — A settlement in the amount of \$1 million was reached in Bronx County on behalf of our client, a 55 year old woman whose foot was run over by a motor vehicle in a private parking lot. Our client sustained a crush injury to her foot, a lisfranc fracture and subsequent arthritis as a result of the incident.

<u>Medical Malpractice/Failure to Diagnose</u> — A settlement in the amount of \$750,000 was reached during trial in Nassau County on behalf of the Estate of a 49 year old mother and special education teacher who passed away after doctors failed to diagnose her colon cancer.

Motor Vehicle/Bystander Injury — A verdict in the amount of \$700,000 was reached in New York County on behalf of our client, a 43 year old real estate agent. Our client, while walking on his lunch break, was struck by a bumper that had flown off of a car during a two car collision. As a result of being struck, our client suffered multiple fractures to his left foot including a lisfranc fracture and a fractured metatarsal. Our client was forced to undergo two surgeries to his foot and had a bone graft procedure performed.

Medical Malpractice/Failure to Properly Perform Surgery — A settlement in the amount of \$650,000 was reached in Middlesex County, New Jersey on behalf of a 46 year old wife and mother of two minor children . Doctors failed to properly perform a myomectomy and punctured her uterus and colon during surgery. Subsequently, our client was forced to undergo restorative surgery to repair the perforations.

Will I have to go to Court?

While nearly all cases are settled out of court and before a trial begins, some are settled after the start of the trial but before its conclusion. Sometimes, if we feel that the settlement offered is unfair to you, we will try your case. We will hold your hand every step of the way. Why do you so frequently win favorable settlements?

There is no guarantee, of course, but at the right point a favorable settlement becomes more likely.

you, and they do not like lawyers abusing witnesses.

Can I afford your services?
